WHEREAS, the Policy Manual Committee has done valuable work to date, but has come to a point where further work should be postponed until the membership has decided whether changes to the Constitution shall be made;

BE IT THEREFORE RESOLVED, that the Policy Manual Committee is put on hold immediately until the membership has ratified any changes they wish to make to the APFA Constitution; and

BE IT FURTHER RESOLVED, that the Policy Manual Committee will reconvene to review the Policy Manual after the membership adopts any changes to the Constitution.
