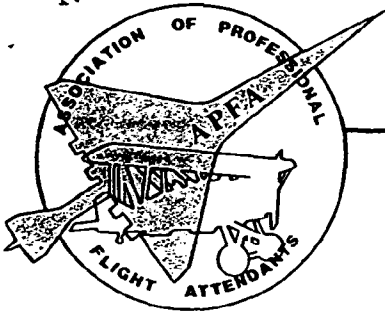

REFERENDUM BALLOT TO AMEND THE APFA CONSTITUTION
Article 3, Section 6, Paragraph A

DUES INCREASE

BALLOT INSTRUCTIONS: Indicate your choices by marking an "X" in the boxes provided. Marking incorrectly shall nullify your ballot.

Please be advised that standing policy dictates that in the event that both an original and a duplicate ballot are received by the National Ballot Committee from one individual, ONLY the original ballot shall be counted.

All ballots must be received at the DFW Airport post office box no later than 0900, July 19, 1982.
